Neighbourhood Planning

- Empowers parish councils & communities to directly shape growth & development in their area.
- Gives a real say on things like green spaces, built heritage, new homes, community facilities, car parking and local employment.
- Results in a statutory plan containing planning policies with real teeth – following a 'YES' vote at referendum.





The Pannal & Burn Bridge Plan

- Nearly 5 years work to date.
- Community input throughout.
- Stop/start preparation process.
- Has to fit with national planning policy
- Has to fit with Harrogate Local Plan
- Has to pass an independent examination





The Policy Intentions Document

- Vision Statement.
- 9 aims.
- 27 planning policy intentions.
- Many 'Non-Planning Community Actions'.
- Your comments are invited on all the above.
- BUT the planning policy intentions are what really matter.





The Green & Natural Environment

- Protect, enhance & extend network of green corridors & links.
- Guide design & development in the Crimple Valley Special Landscape Area.
- Protect a minimum of 8 Local Green Space sites & support their enhancement.
- Support new green space provision allotments, tennis courts & a bowling green.
- Possibly address biodiversity/nature conservation & tree/ hedgerow/woodland issues not addressed in the Local Plan.





The Built Environment: Heritage, Development & Design

- Guide design & development in the conservation area.
- Guide design & development in 3 possible 'Local Heritage Areas' –
 'All Saints', 'Burn Bridge Malthouse Lane' & 'Hill Foot/Hill Top
 Lane'.
- Guide design & development throughout the parish in line with the different characters of each area.
- Seek to safeguard Non-Designated Heritage Assets & to encourage their conservation and sympathetic enhancement.





Traffic, Transport & Travel

- Safeguard, enhance & extend walking/cycling/horse riding provision.
- Encourage enhanced off-street parking standards for new development in vicinity of Pannal Station & Pannal Primary School.
- Safeguard Pannal Station Car Park capacity.
- Support 'Park and Stride' parking on land to rear of Church of St Robert of Knaresborough.
- Support highway improvements at A61/Pannal Bank and traffic calming in areas of evidenced need.
- Support schemes to alleviate west Harrogate traffic congestion.





Community Facilities & Services

- Protect & enhance a list of named community facilities.
- Support provision of new facilities, including a pub in Pannal and/or Walton Park, a café/restaurant & public conveniences.
- Set out detailed layout/design principles for the development of new educational facilities at Pannal Primary School, as allocated in the Local Plan.





Housing

- Set out the mix of housing types expected on any new housing site.
- Set out tests for any new small scale and infill housing development taking place in the parish.
- Set out tests for assessing new housing proposals on unallocated sites.





Economic Development

- Safeguard existing employment sites at Almsford Bridge, Crimple Hall & Spacey Houses.
- Set out detailed layout/design principles for the development of the new allocated employment site South of Almsford Bridge.





Key Next Steps for The Plan

- Preparation of Draft Neighbourhood Plan taking account of Policy Intentions Document consultation response.
- Statutory 6 week consultation on draft plan.
- Amendment of draft plan taking account of consultation response.
- Submission to Harrogate DC.
- Independent Examination.
- Referendum.
